Greetings my brothers and sisters in the faith... Welcome to the family of the Dayspring Ministry Group ...and the Evangelical Christian Church. We hope that as you read this manual that you will listen to God as He leads you into this Christ Centered Fellowship of Churches, Ministries and Ministers.

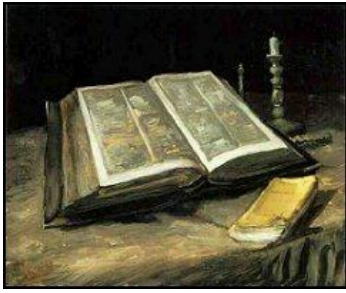

## STATEMENT OF FAITH: *The Seven Articles Of Faith*

---

We Believe...



...there is one God eternally existing and manifesting Himself to us in three persons -- Father, Son and Holy Spirit.

...Jesus Christ is true God and true man. He is our Lord and Savior

...the Holy Spirit is a divine person, sent to indwell, guide, teach and empower the believer, and convince the world of sin, of righteousness and of judgment.

...the Old and New Testaments, inerrant as originally given, were inspired by God and are sufficient for faith and practice.

...Where the Scriptures speak, we speak; where the Scriptures are silent, we are silent.

...the church consists of all those who believe on the Lord Jesus Christ, are redeemed through His blood and are born again of the Holy Spirit.

...the local church is a body of believers in Christ who are joined together for the worship of God, for prayer, fellowship, the proclamation of the gospel, and the observance of the ordinances of baptism and the Lord's Supper.

## MORAL AND SOCIAL WITNESS – ECC & ECC Standing

---

*While these are the official positions of the church, liberty of conscience is allowed on some issues:*

**Abortion** on demand is morally wrong and inconsistent with the Theology of Creation and Existence. However, we are encouraged to be non-judgmental and compassionate towards those who choose abortion in difficult circumstances. Liberty of conscience disallowed.

**Capital Punishment** is inconsistent with the teachings of Jesus and the Theology of Divine Retribution. Liberty of conscience allowed.

**Cloning** is dangerously morally and ethically wrong and inconsistent with the Theology of Divine Creation. Liberty of conscience disallowed.

**Divorce** is a very painful and difficult decision we support when the health, safety and welfare of all involved are compromised. The right to remarry is affirmed. This is consistent with the Theology of Peace and the Divine Plan of Marriage and Family. Liberty of conscience allowed.

**Homosexuality** is outside the Divine Plan of Creation and Reproduction as well as the Theology of Morality. However, we endorse a compassionate and redemptive ministry towards those who struggle with their sexuality. We repudiate all hatred, violence and discrimination.



# REQUIREMENTS FOR ORDINATION – ECC & ECC Standing

---

## Basic Qualifications

The following qualifications pertain to all applicants for ministerial recognition: A thorough understanding of and agreement with the doctrinal position of Dayspring ECC as contained in each Statement of Faith.

A satisfactory working knowledge of the principles, practices and purposes of the Fellowship through a study of the entities of Dayspring Ministries International and their Constitutions and By-Laws. These include The Evangelical Christian Church, The American Association of Christian Therapists, The International College of Christian Therapy.

An active loyalty to the constitutional agreements, a cooperative spirit and a readiness to seek and receive the counsel of those in positions of authority. The same spiritual qualifications shall be expected of the spouse of those seeking credentials. The Christian lifestyle of the spouse shall be compatible with the standards of the ministry.

## Proper Motives



A candidate should be certain that motives are proper in applying for the recognition of the ECC and Dayspring Ministries International. A ministry appointed by the Holy Spirit will prove to be the best credential one can have.

Dayspring and the ECC are founded on the principles of voluntary cooperation. Every applicant ought to feel that the organization of Dayspring ECC is the fellowship or denomination into which God has called them. They are to be one with these people and adhere to the same tenets of faith, principles, purposes and practices as those they now join. They must be one who is committed to the fellowship, willing to not only share in its privilege and blessing, but to cooperate with its ministries. They must be guided by, and when necessary, accept the discipline and direction of its leadership.

Ordination into and standing with The Evangelical Christian Church, Inc. (Christian Disciples) is either by transfer of ministerial credentials or by the "laying on of hands" in a local ceremony under the oversight of an ECC Bishop, Provincial Superintendent or Regional Superintendent. If you are surrendering your past credentials or applying for first time license or ordination you will be received into the ECC. If you are retaining your past credentials you will be received with Standing with the ECC. "Mail order" credentials will be considered on a case by case request. Additionally, we suggest that all candidates for ordination should hold at least a Bachelor's degree in ministry, Bible, theology, religion, pastoral counseling or a related field.

Unaccredited degrees or those accredited by unrecognized bodies will be evaluated by the Ministerial Education Committee. Honorary degrees will suffice if the candidate has life experience. If a candidate does not hold a degree the candidate is encouraged to enroll and complete the courses of study offered by the Christian Ministry Institute. All candidates for ordination must pass an exam on the history, theology and polity of The Evangelical Christian Church, as well as submitting to a personal interview.

The application in this brochure may be used by those seeking Ordination or License. One must be 23 to be ordained and 18 to receive license. Please use an additional sheet of paper to answer some of the questions. If you are 21 and wish to be ordained please call or email the office for special dispensation.

## Making Application For Credentials – ECC and ECC Standing

Contact the Ministries office for a Preliminary Application or print one from the website. Upon receipt of your application you will be notified by email for a phone or personal interview.

Subject to compliance with criteria for eligibility, You may fill out an application from our web page or an application will be mailed to you by the Ministries Secretary. Return the completed application, other pertinent forms, recent photo and filing fee with check made payable to Dayspring Ministries International, P.O. Box 742, Granbury, Texas 76048 USA. If you send credit card or banking information to be paid through Paypal, you may fax your application.

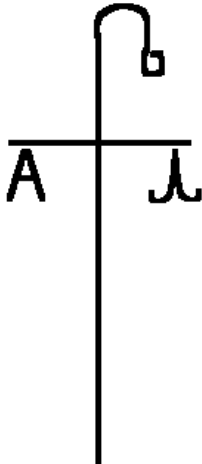
The application will request as references the name of your pastor, ministers acquainted with your ministry background, friends and employers. All references should know the applicant well enough to answer a comprehensive questionnaire. A synopsis of the required examination for those seeking first time license, along with specific study books will be sent to you to assist you in preparing for the examination.

All Certified and Specialized Minister applicants may have to pass a written examination in order to become eligible. Your Pastor or a minister friend will administer the written examination. The Ministries Secretary will notify you in writing that all your references and materials have been received and you will be requested to contact the ministry offices and arrange a time and place for the test to be given. Applicants will be asked to use only their Bible during the examination

## Financial Responsibilities

The work of Dayspring Ministries International, AEC & ECC, in its program of developing the spirit of cooperation and fellowship in home and foreign fields, incurs considerable expense, including the financial support of the national offices. A suggested minimum offering is for each level:

Ordained, Licensed, Senior Retired - Free-will basis  
Suggested \$50.00



## MINISTER'S LICENSE AND ORDINATION LEVELS

**SPECIALIZED LICENSE & ORDINATION** - Many are called to specialized ministry and wish their license or ordination certificate to state such. We license and ordain: Choir Directors, Education Directors, Musicians, Missionaries, local and foreign, and Church Mothers. The License or Ordination Certificate shall read as an example, "Minister of Music," or "Minister of Education," Etc. The Specialized License has five requirements. (1) He or she shall have a call of God on his or her life, (2) Candidate must be 18 years of age for license and 21 years for ordination; (3) Be recommended by three persons, (4) One must be actively involved in a local church; and, (5) The candidate must agree to the giving plan as set forth by the Fellowship and promote Dayspring Ministries International, ECC and AEC.

**LICENSED MINISTER** - This credential is granted to a person who is called of God and wants to step up to a higher order. With a license one is authorized to preach, perform holy matrimony, baptize, serve the Lord's Supper, exhort, confirm, and practice any biblical and religious activity pertaining to the office of Minister of the Gospel, in accordance with respective ordinances of residence. There are three requirements for the Licensed Minister. (1) The Candidate Must be 18 years of age; (2) She or he should have experienced the fullness of the Holy Spirit (Acts 2:4) with the evidence of gifts for ministry; (3) The candidate must agree to the giving plan as set forth by the Fellowship and promote Dayspring Ministries International, ECC and AEC.

**ORDAINED MINISTER** - This credential is granted to a person who has prepared himself or herself for a lifetime of ministry. She or He is certified and authorized to preach, perform marriages, baptize, bury the dead, teach, confirm, serve the Lord's Supper to the congregation. There are four requirements for Ordination. (1) The Candidate must be 23 years of age; (2) The candidate must be ready to commit his or her life to God's calling until He shall come again. (3) She or He will have experienced the fullness of the Holy Spirit (Acts 2:4) with the evidence of gifts for ministry; (4) The candidate must agree to the giving plan as set forth by the Fellowship and promote Dayspring Ministries International, ECC and AEC

## CHURCH CHARTERS

---

The Association of Evangelical Clergy will offer charter to ministries. The Evangelical Christian Church will offer charters for churches and ministries (if requested) who are pastored by ECC and AEC Licensed or Ordained Ministers. There is a one time filing fee of \$50.00.

Chartered Churches and Ministries are requested to send a monthly offering to Dayspring Ministries International. Churches received into the membership are encouraged to provide monthly offerings as a base of support for the operation of the administrative office and the development and furtherance of benefits, study materials, and support of member ministries in need. All giving should be done in faith, with a heart of love and a commitment to sowing seed into good soil. (Luke 21:1-4; 2 Corinthians 9:7)
